



## **Examiner Mentor**

As of September 1, 2019 future Bronze, First Aid and National Lifeguard Examiners must do their co-exam(s) with a current examiner who has been appointed as an Examiner Mentor. Examiner Mentor is a new designation and refers to senior Lifesaving Society examiners appointed by the Society to mentor examiner candidates through their apprenticeship phase and approve them for examiner certification.

An initial group of experienced examiners who have conducted a minimum of three exams and have strong leadership and administrative skills, will be offered appointments as Examiner Mentors by the Society in June. They will be asked to accept the responsibilities outlined in the Examiner Mentor job description:


- Provide effective apprenticeship experiences for examiner candidates including evaluation of their performance and guidance on their professional development as potential Lifesaving Society examiners.
- Complete Lifesaving Society administrative requirements in a timely manner including completion of training records for the apprenticing examiner candidate.
- Assist in the identification, recruitment and development of potential Lifesaving Society examiners.
- Act as expert resources to Lifesaving Society apprenticing examiner candidates in matters related to Lifesaving Society evaluation standards.
- Attend Examiner Mentor workshops and clinics as required.

## National Lifeguard Mythbusters — The Pre-cert

The Society's dedicated affiliates host National Lifeguard Recertifications frequently to ensure certified National Lifeguards stay current and up to standard. The Society sets the "rules" for all National Lifeguard exams in its National Lifeguard Examination Policy, including recertification. Over the coming issues of Currents, we'll separate fact from fiction on what's inside, or outside, the Society's National Lifeguard Examination Policy. In this issue we address the myth: you **must** attend a pre-cert prior to a National Lifeguard recertification.

Pre-cert is a training session offered for candidates before a National Lifeguard recertification. Although some affiliates may mandate staff training prior to a National Lifeguard recertification, it is not a requirement in the National Lifeguard Examination Policy. The only prerequisite required to attend a National Lifeguard recertification exam is a National Lifeguard certification.

It is important to remember that recertification exams typically do not schedule additional practice or instruction time, so come prepared. If you need to brush up on your skills, attending a pre-cert is a good idea.
